PUBLIC TENDER FOR INVESTMENT IN LOBITO REFINERY

Sonangol E.P. hereby informs that the Public Act of Validation of Proposals, referring to the Public Tender for Investment in the Lobito Refinery, in which Sonangol E.P. will open / validate the proposals and announce the companies whose proposals are in conformity, to pass the evaluation phase of proposals, takes place on October 15, in Benguela, in the building of the Municipal Administration of Lobito, at 10 am.

Due to the restrictions imposed by Covid-19, Sonangol requests companies to indicate only one representative to physically participate in the public act of validation of the proposals.

The period for submitting the proposals ends on 14 October, so all registered and interested parties must submit the proposals by the deadline set, in accordance with the instructions presented below:
